Mr. Holowach stated there were two salting snow events since last meeting. Mr. Holowach stated with the cold snap, there were three water lines that bursted in homes in which the DPW was involved with. There was also a sewer repair on Clove Avenue. Mr. Holowach stated there has been continuous work on the Route 23 water service lines. Mr. Restel stated the issue has been the water service line going to the DAR. It's about a 2,000-foot run that goes directly through Clove Brook which has completely frozen over. The DPW has been up there trying to repair it. They're working on getting a price quote for the repair.

Mr. Fronheiser offered no report.

Mr. Cleary stated they went to the League of Municipalities meeting, but he will refer to Mr. Meyer about the meeting since he took extensive notes there.

Mr. Brennan offered no report.

Mr. Meyer stated since he missed the Budget Meeting, he sat down with Toni and Mike to go over it. Mr. Meyer stated on January 28, 2019, they had a Planning/Zoning meeting. They are going to present to the Mayor and Council, Planning Area B, the redevelopment zone. Mr. Meyer stated

outside entertainment regulations and temporary use, or event permits were also discussed at the meeting. The proposed Ordinance will follow. The reason for this is because of the events that are occurring and no one is aware of it. Mr. Meyer stated he attended the League of Municipalities on January 30, 2019. Senator Oroho did a great presentation on Path to Progress. Mr. Meyer stated on January 30, 2019, Rich Klein, Ken Nelson, Mike Restel, Tom Madsen and Tammie Horsfield met to discuss the Sussex County Economic Development Partnership. They made several recommendations, one of which was to set up a Sussex Economic Development Council. They suggested to create on the website a complete list of available properties, amenities in the community, links to Planning and Zoning, information on the Opportunities Zone and contact information for the Planning/Zoning, Tax, Council and Mayor. They offered to help with an overall strategic plan. Mr. Meyer thanked Mr. Holowach for manning the warming stations on Thursday and Friday.

Mayor Little stated on January 22, 2019 we held our Budget Meeting. Mayor Little stated on January 28, 2019, was the Planning/Zoning meeting, Mr. Meyer gave the report. Mayor Little stated on January 30, 2019, five of us attended the Sussex County League of Municipalities meeting at the Mohawk House. Senator Oroho was the guest speaker. He gave a presentation on the "Path to Progress" recommendations. Mayor Little stated on February 4, 2019, we had a meeting to discuss the water lines on Route 23 South. The Borough has been notified that they will receive \$400,000.00 through SAGE, through a Small Cities CDBG 2019. The grant is for Willow Street, Ley Place water lines and to replace 12 manholes. It is necessary to repair two manholes as soon as possible on Walnut Street before it is paved. This is a priority.
