# MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF SUSSEX HELD AT THE SUSSEX MUNICIPAL BUILDING 2 MAIN STREET, SUSSEX, NJ AT 7:00 P.M. ON AUGUST 13, 2019

Council President Meyer led the assembly in the flag salute and requested a moment of silence.

<u>Council President Meyer</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq. It has been properly advertised and certified by the Clerk."

#### **APPROVAL OF AGENDA**

Mayor Little made the following statement via phone:

Mayor Little stated Sussex Borough has received a grant for \$1,018,800.00 from the USDA. A letter of intent was signed on August 7, 2019 accepting the funds on behalf of Sussex Borough. This award will provide partial funding to install a waterline from Lake Rutherford directly to the water treatment facility. The source of the drinking water for Sussex Borough is Lake Rutherford. By installing this waterline, drinking water will be delivered directly to the treatment facility best reducing the impurities that the water could contain as it arrives for treatment at the plant. Treatment cost will be reduced as less chemicals are necessary. A major benefit for customers is the expected improved water quality that will be provided to them. The grant application was mailed on behalf of Sussex Borough and the grant writing consultant Bruno Associates of Clifton, New Jersey. In FY 2017, \$400,000.00 was granted for this waterline project from small cities block grant. When combined with the USDA grant funding of \$1,418,800.00 in grant money is available for the project. This is envisioned to other funds obtained for Sussex Borough and to date that amount is \$2.9 million and they have been receipts to do various improvements to Sussex Borough's utilities by Bruno Associates director, Steve Welch. That is the statement of \$1,018,400.00 that is being set aside, down in the state of New Jersey for our project.

#### **PUBLIC HEARING:**

Steve Welch, from Bruno Associates, read the following statement:

The Borough of Sussex, New Jersey will hold a public hearing on August 13, 2019 at 7:00 p.m. in the Municipal Building, 2 Main Street in the Borough of Sussex, New Jersey.

The purpose of the hearing is: (1) to explain federal and state guidelines, (2) to review eligible and proposed program activities, (3) to consider proposals for an application under the Small Cities Community Development Block Grant Program, and (4) to receive citizen comments and recommendations.

This is a Federal program which has \$6,537,428 in funds to award in New Jersey as follows:

Public Facilities - \$4,517,428 Housing Rehabilitation - \$800,000 Innovative and Economic Development - \$1,200,000 Emergency Housing Repair - \$20,000

At least 70 percent of the funds available must be used for activities that primarily benefit people of low and moderate income. None of the funds requested will result in the displacement or relocation of people.

Eligible activities include:

- 1. Acquisition of real property;
- 2. Acquisition, construction, or installation of public facilities;
- 3. Code enforcement in deteriorated or deteriorating areas;
- 4. Clearance, demolition, and rehabilitation of buildings;
- 5. Special projects to remove architectural barriers which restrict accessibility of the elderly and handicapped;
- 6. Provision of public services;
- 7. Activities necessary to develop a comprehensive community development plan and policy planning management capacity to enable the recipient to more effectively administer the program;
- 8. Payment of reasonable administrative costs; and
- 9. Activities carried out by public or private non-profit organizations.

The Borough of Sussex is proposing an application in the amount of \$400,000 for the Water Distribution Improvements Project to replace water lines under Main Street, install a new water line to the water storage tank, and install additional insertion valves.

The purpose of the hearing is to review the performance of and receive citizen comments and recommendations concerning the Small Cities Community Development Block Grant, awarded in 2018 for Public Facilities for the following:

- 1) Replacing the water line running under the Loomis Avenue bridge
- 2) Installation of a pressure reducing valve at the water treatment plant
- 3) Identification of dead-ends in the system
- 4) Removal of the dead-ends
- 5) Installation of ten new water valves

The Borough of Sussex received a grant in the amount of \$400,000 for the Water Distribution System Improvements Project.

#### **Open Public Session**

We currently have permission from residents to go in and do surveys to make the meets and bonds of the easements. Upon completion the tech specs for the removal of the dead ends will be put in. Regarding, the installation of the valves, bid specs were submitted to Bruce Benton for review. Upon approval, it then can move forward. Mr. Holowach asks if the PRV and the water treatment plant are designed for when Lake Rutherford is completed. Mrs. Smith was unsure.

Mr. Brennan arrived at 7:30 pm.

Council President Meyer closed the hearing to the public.

<u>Council President Meyer</u> gave a brief overview on the preliminary discussion on the firewood boxes and clothing bins. The Planning/Zoning Board has requested Council look into all the firewood boxes and clothing bins in the Borough as they seem to be "popping up" all around town. The Board advises to mirror an Ordinance to only allow them on commercial property. <u>Mr. Fronheiser</u> stated there are only two clothing bins and one firewood box in town.

Mr. Holowach held a discussion regarding the sidewalks on Main Street and Newton Avenue. Mr. Welsh stated that they have tried once before for a grant for the sidewalks and it was denied. He stated they can apply for it again as there's no deadline using the same materials from the previous grant. Mr. Meyer discussed lighting as well on Main Street. Mr. Poggi discussed designing an amphitheater in Decker Town Commons.

<u>COMMITTEE REPORTS</u>: <u>Council President Meyer</u> opened the floor to each member of the Council to offer their respective committee reports.

Mr. Demarest, DPW Supervisor, gave an overview of projects they are working on and projects that need to be addressed.

Mr. Poggi stated he review and signed off on the vouchers Saturday, August 10, 2019. Mr. Poggi offered no report on personal. Mr. Poggi stated in next year's budget he would like to propose \$2,000.00 for a County sign to be put out for the Union House.
