<u>Mayor Little</u> called the meeting to order and requested the clerk to call the roll. # **DISCUSSION:**

Mr. Meyer held a discussion regarding the Route 23 Redevelopment Plan pertaining to Area B.

<u>COMMITTEE REPORTS:</u> <u>Mayor Little</u> opened the floor to each member of the Council to offer their respective committee reports.

Mr. Fronheiser stated the Board of Health did not have a meeting. Mr. Fronheiser asked Mrs. Smith if anything has been established with the County regarding the salt shed. Mrs. Smith answered she has been in communication with the County. They are sending a proposal for the shared services for the salt. Mr. Fronheiser asked Mrs. Smith if the refund for the lake has been received. Mrs. Smith answered yes. Mr. Fronheiser asked Mrs. Smith about the wall at the DPW garage. Mrs. Smith stated so far two masons have come out to examine the garage, but no one has yet submitted an estimate for the work. Mr. Fronheiser asked Mr. McGovern about renting the sign in front of the Municipal building to the theater and local businesses. Mr. McGovern stated he still has to research it. Mr. Fronheiser stated Hill Street is still not done and the theater stairs still are not fixed. Mrs. Smith stated she will check with Brain from DPW. Mr. Fronheiser stated also the water issue behind Taco of the Town has not been resolved. Mr. Meyer stated to ask Mike Vreeland from the Planning Board to go out and look at it. Mr. Fronheiser asked what is the problem with the ladder truck. Mayor Little stated it was due to electrical issues. Mrs. Smith stated Floyd, from the Fire Department, reached out to her via text that the front brakes and calibers on the ambulance need to be replaced at a cost of \$2,000.00. Mr. Fronheiser asked about the fixing of the sidewalks on Main Street. Mr. McGovern held a discussion about the repairs of the public and private portions of the sidewalks. Mr. Fronheiser asked Mr. Poggi how many shows does the theater do a month and how often are they using the parking. Mr. Poggi stated rehearsals for a show is six weeks and the actors would need to utilize the parking. Mr. Fronheiser held a brief discussion about the parking spaces.

Mr. Cleary offered no report.

Mr. Brennan stated everything's coming together for Sussex Day on October 20, 2019. There are multiple bands booked. The street will close beginning at 10 am. Mr. Meyer stated there will be a petting zoo and at noon will be the parade. Recreation will hold their next meeting on Wednesday,

September 16, 2019. Mayor Little stated the Halloween parade is at noon. Mr. Meyer stated the petting zoo is at 1:30 pm.

Mr. Poggi stated he came in on Saturday, September 14, 2019 and signed off on the bills. Mr. Poggi had nothing to report on personnel. Mr. Poggi stated on Saturday, September 21, 2019, he will be running Sussex County History Day in Newton. There will be about 13 Historical Societies lined up along with a Civil War reenactment and bands. Also on Saturday, there will be the Old Newton Burial Tour. Sussex County History Day is free of charge, but the tour is \$10.00. They are narrated by characters in costumes.

Mr. Meyer stated for Sussex Day, Norwescap is allowing them to take one of their store fronts where they can put Sussex Borough "then, now and future" films to run. Mr. Meyer stated he did relay to the Planning Board that the Council is waiting for whatever the County and the State come up with regarding the dirty dirt. Mr. Meyer also relayed to the Planning Board that the Council had no interest in the fire box Ordinances. Mr. Meyer held a brief discussion on the Property Maintenance Committee. Mr. Meyer stated the developer for the bank property will be making an informal presentation to the Planning Board, tentative date is October 16, 2019. One of the key things is to have the right of way identified that is behind Main Street on the Mill Street side. Mr. Meyer held a discussion regarding temporary outdoor use permit requirements.

Mayor Little stated Monday, September 16, 2019 she spoke with Dave Pepe, from the NJDEP Permitting Department and he said as far as the State is concerned right now with the Lake Rutherford waterline coming down to Colesville, the State is satisfied with everything. We still do have to have the easement for the agricultural in condemnation process that we have to go to see about in getting this done. Mayor Little stated we also have to get our Engineer from Houser to do the construction schedule. Mayor Little stated even though she is unable to come down to the Borough Hall, she does keep in touch.
