They will begin with a billiard pool hall with light snacks, an ice cream bar and a regular bar when the liquor license is approved. If it falls through, the other alternative is to lease it out to other establishments. Mr. Meyer stated there was report on the SAFER grant, which are for outfits for the firefighters in the amount of \$49,000.00 which was filled out and now they are just waiting for that to be determined. gear. Mr. Meyer stated they are working on getting a viable project for Small Cities and Mike had suggested the watermain going up to the water tank. Mr. Meyer stated they are finishing up the USDA grant. Mr. Meyer stated the USDA has an Economic Impact Program, where 75% of the cost is for sewer pumping stations, repairs and replacements. Mr. Meyer stated they had a very good meeting with NORWESCAP regarding the building on Main Street and types of businesses they could put into the empty store fronts. Mr. Restel added the Safety Grants provides funding for sidewalks, parking lots and lighting. They can assist with the Borough parking lot and lighting.

Mayor Little stated on April 5, 2019, there was a meeting with NORWESCAP with Chris Kirk and CEO Mark Valli, to discuss options for use of the building on Main Street. Mayor Little stated on April 4, 2019, she had a weekly phone call with Dave Pepe, who is with the State DEP and is working with Dan Ryan of the NHR, regarding the Borough's waterline. Soheil, from Houser Engineering, is working on the maps for the easement and Dan Ryan is the advisor to Commissioner McCabe. Dave will contact Dan to work on the timeline of the Lake Rutherford waterline project. Mayor Little stated on April 8, 2019, there was a Planning/Zoning Board meeting. There was a presentation from a businessman with plans for a building on Main Street. Mayor Little stated on April 10, 2019, the Grant Committee held a meeting to review the Borough's grants. Mayor Little stated on April 11, 2019, she met with Ed Meyer to discuss various items. Mayor Little stated on April 13, 2019, the Borough Recreation held their annual Easter Egg Hunt, which went well. In the evening, the fireman and EMS held their annual dinner in which Councilman Fronheiser, Councilman Meyer, Councilman Poggi and Councilman Brennan were in attendance. Mayor Little stated on April 16, 2019, she met with Ron Bassani, Wantage Mayor, to discuss a few items.
