Mayor Little led the assembly in the flag salute and requested a moment of silence.

<u>Mayor Little</u> called the meeting to order and requested the clerk to call the roll. PRESENTATIONS:

Jackie Espinosa of Jersey Central Power & Light (JCP&L). Ms. Espinosa gave a presentation on the JCP&L Reliability Plus Program. The program is designed to help with utilities. Ms. Espinosa stated the plan is to spend \$400 million in four years. The plan also outlines vegetation management to reduce the potential for tree damage, which is the primary cause of outages during severe storms in JCP&L's service area.

DISCUSSION:

Matt VanderBush, representing Sussex/Wantage Little League. Mr. VanderBush held a discussion about the conditions of Brookside Park. Mr. VanderBush stated the fields are rough to play on and asks if there has been any future discussion about the conditions. Mr. Restel stated many years ago there was grant money issued for fields, but it is unknown what has happened to that money. Mr. Restel stated he would need to get the Borough Engineer there to look it over. Mr. VanderBush stated he would like to look at it as a park and put in a long term plan to include a basketball court and playground.

Mr. Poggi stated he received a call/text from a resident asking if he could intervene in a problem. The resident called Borough Hall stating his landlord has not provided him with heat

and he was advised to contact the State. Mr. Poggi stated he read the State law and the Borough can enforce that law through the Local Health Department. Mr. Poggi stated he found it odd that the Borough did not have an Ordinance on heat law and would like to see an Ordinance enforcing it. Mr. McGovern stated he believes there is a housing code in which that law falls under. He will look into it and get back to the Committee.

<u>COMMITTEE REPORTS:</u> <u>Mayor Little</u> opened the floor to each member of the Council to offer their respective committee reports.

Mrs. Masson stated there was a Grant Committee Meeting on October 15, 2018. They discussed everything that was going on and things that they might be interested in, in the future. Mrs. Masson stated a question came up at the last meeting about the Opportunities Zone. As Steve explained, that is not for the Town to apply for. It is really for the Developers or Business Owners who may want to move into the Borough who are looking for some tax incentive. Mrs. Masson stated they also talked about the completed projects such as the Lake Rutherford Dam. Mrs. Masson stated there are some more meters that need to be installed. Mrs. Masson stated the one area of concern is the water line. The Borough has received \$400,000.00 for that project which expires at the end of this year. Mr. Restel stated they have put in for an extension. Mrs. Masson stated they put an application into the USDA to get most of the remaining funding. The cost of the projected increased to \$2 million due to changes in the project. Mrs. Masson stated they are requesting \$1.5 million from the USDA. The USDA has put our application on hold because they need an updated cost sheet, the preliminary Engineering report and the Environmental report.

Mr. Cleary offered no report.

Mr. Brennan stated they did not have their Recreation Committee meeting because they did not meet a quorum. They put together the bags for the Halloween Parade instead. The parade is scheduled for Saturday, October 27, 2018 at 1:00pm at Deckertown Commons Park. Mr. Brennan offered no Board of Health report.

Mr. Poggi stated he came in Sunday, October 14, 2018 to approve the bills list. Mr. Poggi stated nothing new to report on personnel. Mr. Poggi stated nothing new to report as the Historian.

Mr. Meyer stated the Planning/Zoning Board meets next week.

Mr. Holowach stated the DPW is putting down crack seal around the Borough. Mr. Holowach stated he would like a letter sent out to those requiring a new meter. Mr. Holowach stated road salt has been delivered and the salt trucks are full and ready for the winter.
