MINUTES OF THE MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF SUSSEX HELD AT THE SUSSEX MUNICIPAL BUILDING 2 MAIN STREET, SUSSEX, NJ APRIL 19. 2016

No presentations were scheduled for tonight's meeting.

<u>COMMITTEE REPORTS:</u> <u>Mayor Little</u> opened the floor to each member of the Council to offer their respective committee reports.

Mrs. Stoll stated that the Recreation Committee did not have a meeting because there was not a quorum. There was a special meeting at Sussex Wantage School that three of us attended. The Sussex Wantage School will come to present their budget after it is approved.

Mr. Meyer stated the Planning/Zoning Board meeting was adjourned until April 25, 2016. The water/sewer rate structure committee met on April 12, 2016 and held a discussion regarding the

scope of the committee and from that we have several recommendations that are unanimous which are that the meetings should be open to the public, the meetings be recorded and that the recordings of the meetings be posted on the website and posting the meeting dates on the website and on the bulletin board the week before the meetings and will meet once a quarter. Update the rates on the website because the rates are incorrect. Also we are requesting that we get more increased code enforcement for follow up on edu changes. We also recommended the ordinance that is on tonight for destroyed property with the following addition where there would be a status review within one year from the date of the loss. Some questions that came from the meeting, how will we budget for when the clerk, attorney or other staff is needed? Are there any liability concerns for members and is the committee covered by borough insurance? There have been some concerns about businesses being run in residential zones.

<u>Mrs. Masson</u> read the following prepared statement: "Our Borough has been struggling with Mr. Parrott and his Sussex Inn's non-payment of money owed to the Borough on and off for at least the last five years.

Mr. Parrott's current attorney, George Daggett, has interjected himself in the matter of a payment plan for the redemption of the Sussex Inn tax lien held by the Borough. Mr. Daggett has tried to influence the outcome of a vote via threats and intimidation. I liken this to "jury tampering". I find his statements about me libelous.

As a councilperson, I take my oath of office seriously. It is my responsibility to represent all Borough taxpayers equally.

I didn't take direction from Mr. Parrott's previous attorney, who is now facing a legal proceeding for withholding from us his dual representation of the Sussex Inn, while also acting as our municipal attorney. I certainly will not relinquish my ethical responsibilities by taking direction from Mr. Parrott's current attorney, who has twice been cited by the same state ethics board that is dealing with Mr. Ursin.

It is the responsibility of this governing body to make decisions on matters put before it that do not indicate favoritism but rather reflect what it best for ALL residents of the Borough we serve and to do so with transparency. We must always be careful of setting dangerous precedents which open the Borough up to lawsuits."

I attended the water/sewer rate structure committee meeting. I also attended the Sussex Wantage School meeting on April 6th and I had spoken twice about the need to reduce their budget and the fact that they have reduced their student count by 670 in the last 15 or so years. I asked them if they had looked into closing one of the schools. I asked the superintendent for a total by school. The grant committee met this morning and we went over all of the grant applications that are out there. We should hear in May about the USDA grants. Also, in May the H2Loan should be determined and that is half loan forgiveness. Mr. Welsh is very confident that we stand a very good chance of receiving these grants. There was a report for the Small Cities CDBG for the lake Rutherford dam that should have been received today from the engineer. There is a recreational trail grant that the Clove Lake Maintenance Committee should look into. There is a sewer main repair local aid infrastructure fund, this program funds emergency infrastructure improvements. There's no limit to the request for funds and no match required; the only requirement is that the project must be an emergency. The small cities CDBG grant, Steve Welsh is looking to put in for that again for realignment of the intake line at the plant and that is coming out at the end of June. Safe routes to school, we were discussing this, it's another grant and I asked him about Main Street.

Mr. Dykstra offered no report at this time.

Mr. Holowach stated that the DOT punch list is still open for the Route 23 project. The dehumidifiers and sump pump were installed in the dry well which is down by the sewer pump at the DPW property. The water leak on Clove Avenue, a contractor will be here on Friday to dig that up. There is a hydrant flushing schedule out and the DPW will be using the camera to determine if there is anything running into the sanitary sewer. The containment area repairs, the caustic was cleaned and there are plumbing repairs that are happening in that space. We are doing chlorine piping repairs in that same area. Valves and actuators are being rebid. Gerry is getting numbers to repair the floc tanks.
