# MINUTES OF THE MEETING OF THE MAYOR AND COUNCILOF THE BOROUGH OF SUSSEX HELD AT THE SUSSEX MUNICIPAL BUILDING 2 MAIN STREET, SUSSEX, NJ AT 7:00 P.M. ON JANUARY 21, 2020

Mayor Meyer led the assembly in the flag salute and requested a moment of silence.

<u>Mayor Meyer</u> stated "This meeting is being held in compliance with the provisions of the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq. It has been properly advertised and certified by the Clerk."

#### **APPOINTMENT OF COUNCIL MEMBER:**

<u>Mayor Meyer</u> stated Mrs. Alexis Horvath read for the record the names submitted on January 17, 2020 from Charles Fronheiser, Jr. and Alexis Horvath, Sussex Municipal Republican Committee.

Alexis Horvath, Sussex Municipal Republican Committee Chairwoman, read the three names that were submitted ad most qualified; Barry Fitzpatrick, Linda Masson and Thomas Prout. Mrs. Horvath stated they nominated Mr. Fitzpatrick would be a great candidate. He purchased a home on Banks Street in which he put a great deal of not only money, but a lot of energy in house. He has also put a lot of money into his business on Mill Street as well. He has a vested interest and feels he would be a wonderful asset to the Council. Mrs. Horvath stated Mrs. Masson's nomination was a given since she was already on the Council. She is aware of what is going on in the Borough. She has a good response with the Borough employees as well as the Council. Mrs. Horvath stated Mr. Prout is another person that would be great. His family owned a very successful business in Town, Prout's Diner. He ran the business with his brother. He is very involved with the Town. He was very integral in getting the Sussex Wesslyn Church back on their feet to open back up and now their doors are open. Mrs. Horvath stated the statue of the nominations of filling a vacant seat. Mrs. Horvath stated the residents of Sussex Borough have entrusted in Mr. Fronheiser and herself to do their homework and due diligence in regards to what is best and positive representation for the Borough and benefit of the Borough. Mrs. Horvath stated she is not thrilled that the Mayor went behind her back and discussed with a brother of a candidate and see why he would want to represent the Borough on Council. She does not feel that it is proper nor was it an ethics violation, but she feels that he should have spoken to herself or the Committee man. Mayor Meyer disagrees with Mrs. Horvath and stated he has the right the responsibility to vet each and everyone one of the candidates, in which he did. Mayor Meyer stated he spoke with Mr. Fitzpatrick and Mr. Prout to discuss their view points. Mrs. Horvath stated she did not feel he should speak to someone who is not a candidate. Mr. McGovern confirmed with Mrs. Horvath the submitted candidates are residents of Sussex Borough and are all registered republican voters.

Mr. Poggi stated during Executive Session, there will be a discussion of the hiring of a part-time parking enforcement officer. Mr. Poggi stated he attended the NJ Local Planning Service meeting on January 10, 2020 along with Mayor Meyer. Mr. Poggi stated it is pretty interesting in the amount of services the state will provide for free. Mr. Poggi stated there is a reality show where they fix up houses and a Town. He will be putting in an application to rehab Sussex Borough. He advised others to put an application too.

Mr. Fronheiser stated he met with the DPW and was told they have been trying to get a hot water heater and was told there was no money for it. It has been leaking water on the floor. Mr. Holowach asked to get amounts on flipping the one of the two restrooms, do a unisex bathroom and making the other a shower stall. Mr. Fronheiser stated there was also a discussion on getting a Borough Physician. Mayor Meyer stated per the DPW Supervisor, there are certain vaccination that the employees should have. Mr. Fronheiser stated he had a few more items for discussion that will be left for the Budget Meeting. Mr. Fronheiser stated the State passed the Dirty Dirt Ordinance and there is a pile down at the garage and would like to know what is going to be done with it. It is very costly to get rid of it. Mr. Fronheiser voiced his concern on the DPW not wearing the uniforms that have been supplied to them. Mr. Fronheiser offered no report on Property Maintenance. Mr. Fronheiser held a discussion on the replacement of fire hydrants.

Mr. Cleary stated he was unable to attend the SCUMA meeting. Mr. Cleary stated Mr. Fronheiser covered everything regarding the DPW meeting.

Mrs. Masson stated she attended the Grant Committee meeting. Mrs. Masson stated the CFO was in attendance to go over the financial situation of the water/sewer system. Mrs. Masson stated typically they would go over the all the grants available, what we would like to put in for,

what we have received and the work in the progress. Mrs. Masson stated that Mayor Meyer said that due to the Water/Sewer Utility's financial situation, as stated by our CFO, he did not want to pursue any new grants. Mayor Meyer stated we needed grants for the projects as there are so many incomplete and to add more projects without full grants wouldn't make sense. Mayor Meyer stated the CFO and Auditor made it very clear on some of the restrictions and limitations that we had and adding more grants, until the currents projects were completed was the recommendation. Mrs. Masson stated we need to complete the work for which we already have grant money, otherwise, we put the ability to obtain future grants in jeopardy. She suggested that the Grant Writer attend a future meeting to discuss grant availability and the needs of the Borough with the Council, as it is their decision.

Mr. Brennan stated he attended the Recreation meeting. They discussed a few events that are being planned.

<u>Mr. Holowach</u> stated he attended his first Planning/Zoning Board meeting and gave some information from the meeting. <u>Mr. Holowach</u> held a brief discussion on the Harvest House and NORWESP. There was discussion on lighting as well.

Mr. Poggi added a discussion from the meeting of the Local Planning Service.

<u>Mayor Meyer</u> stated he and Toni had a follow up call from the Local Planning Service. <u>Mayor Meyer</u> stated there was a discussion regarding a redevelopment plan for the hospital. <u>Mayor Meyer referred to his report.</u>

Mr. Fronheiser requested status on the hot water heater for the Municipal Building and the DPW Garage. Mrs. Smith stated she is still waiting on quotes.
