<u>Mr. Fronheiser</u> stated there was a meeting with Houser and DeBlock. They were advised the water tower needs a mixer which is \$35,000.00 and electric is required to run this, a PRV valve is needed on Smith Road to allow that to be remotely controlled. They want to give a price for hydro testing/mapping. <u>Mr. Fronheiser</u> stated we need to find out who owns Roy Court. <u>Mr. Fronheiser</u> asked who is responsible to fix the waterlines going up Route 23 by the DAR, by the school and Shoprite Liquors.

Mr. Demarest, DPW Supervisor, stated the street sweeper continues not to work correctly. He stated it has been in and out for service and repairs, but no issues can be detected.
